This panel discussion, organised by Equinet, the European Network of Equality Bodies, will aim to inform participants on recent developments in European anti-discrimination legislation and discuss future opportunities to help them support the advancement of equality in Germany and in Europe. Diverse speakers working on equality at the European level will present progress made in recent years and remaining gaps. This will include the importance of the implementation of standards for equality bodies and the existing, new and foreseen legislation, such as the Work Life Balance Directive or the Gender Equality Strategy.

The workshop will also discuss the need for completing the EU legal framework on equal treatment, notably by the adoption of the Horizontal Anti-Discrimination Directive. The speakers will share their work from the perspective of Civil Society and the European Commission and address how the German Presidency of the Council of the EU can achieve significant progress on European anti-discrimination legislation and how the participants can contribute to making Europe more equal.
