



# EQUINET Training – Programme Access to Rights

### **GENERAL INFORMATION**

# Training seminar duration (1.5 days)

- Participants arrive in the evening or afternoon before day 1 (Monday 27 April 2009)
- Day 1 is a full training day (Tuesday 28 April 2009)
- Day 2 is a half day training ending after lunch at 14h00 (Wednesday 29 April 2009)

#### Location

The training venue — Coach House (Dublin Castle) is located in the Dubh Linn Gardens, situated in the very heart of Dublin City, on the south side of the River Liffey, off Dame Street, en route from Trinity College to Christchurch Cathedral. ### **Participation**

- Around 40 participants (including speakers, facilitators and staff members)
- Maximum <u>2 participants per Equinet member organisation and 1 for observer</u> Equality Body

In order to make the most out of the training seminar, it is requested that selected staff members participating will be able to attend the whole seminar and are able to follow the training and engage in discussion which will be primarily in English.

## Language

The main language of the training will be English.

#### Travel and Accommodation

Both travel and accommodation costs of participants will be covered for by the Equinet Budget.

Travel will be arranged by participants themselves and reimbursed by Equinet subsequently and upon submission of the claim form and supporting tickets / invoices (2<sup>nd</sup> class travel ticket and local travel, max €350 in total, all costs inclusive). Participants need to arrive on Monday 27 April as the training seminar will start early at 9.30 on 28 April.

# **AIMS AND APPROACH**

#### Background

The low level of knowledge of rights and absence of culture of rights are one of the main obstacles in achieving full equality for all. This also results in low number of claims and court cases concerning discrimination.

To challenge this reality it is needed to raise public awareness on equal rights and tools of combating discrimination and to identify the ways of approaching (potential) victims of unequal treatment.

Providing information on rights is one of the most important duties of national equality bodies. Most of National Equality Bodies (NEBs) have already worked out their own strategies in relation to this duty and have gained a great number of experiences in this field. Equinet's training should create an opportunity to share all these experience with others.

There are 3 main goals of the training:

- Exchange NEBs' experiences and good practices in providing information on rights
- Provide an understanding of vulnerable groups' needs in relation to information provision and effective ways of communication with vulnerable groups
- Work out the strategies with collaboration with other stakeholders active in the field of equality

#### Method

There will be three rounds of plenary sessions and two workshops. Basing on the feedback from participants of previous Equinet's trainings, it was decided to pay special attention on the possibility of exchanging experiences and good practices among equality bodies from all over Europe. <u>Mutual learning and sharing NEBs</u> experiences with others will be core activities during the training.

<u>During the whole training the issue of horizontal and transversal perspective on different grounds of discrimination will be present.</u>

The objective of the first session is to present 2 national examples on providing information on rights and to focus on the role of equality bodies as important and unique providers of information on rights. The objective of the second plenary is to create a platform for discussion on how to communicate with target groups as well as potential collaborators of equality bodies.







# Workshop 1

There will be three small discussion groups (15 - 20 people). In each group there will be one 20 minutes of presentations from national or European NGOs representative(s) (sexual orientation, disability, race) + discussion with participants. Even though the NGOs contributing to the workshop 1 are single ground organisations, horizontal and transversal perspective on different grounds of discrimination will be discussed. Each discussion group will be facilitated by a moderator/speaker (selected from NGO) and there will a rapporteur from equality bodies participating nominated. The main goal of this workshop will be

- to discuss how to cooperate effectively with the target groups and reach their needs
- to discuss internal capacity of equality bodies
- to discuss innovations in targeting and communicating with vulnerable groups.

## Workshop 2

Each discussion group will be asked to build a strategy how to work in partnerships in providing information on rights. Discussion groups will be moderated by representative of national/European trade union/business/citizens information provider who will give the report at the last session. The strategy should be focused not only on external needs but also participants will be asked to look at internal needs within their equality bodies.
