## **Glossary**

- **UN CRPD:** United Nations Convention on the Rights of Persons with Disabilities Ratified by the EU and 25 Member States (FI, IE and NL still have to ratify it).
- UN Committee on the Rights of Persons with Disabilities: Made up of independent experts, in charge of monitoring the implementation of the CRPD by its state parties.

# The European Parliament adopts its annual report on Human Rights in the World

In March 2015, the European Parliament voted its annual report on human rights in the world. The report addresses thematics such as death penalty, business, freedoms of expression and religion, and rights of LGBTI people. It makes recommendations to EU institutions, EU Member States, international institutions and States to improve and better protect human rights.



# **European Semester: the European Commission publishes the 2015 Country Reports**

In the context of the 2015 European Semester, the European Commission published its Country Reports, providing an overview of the economic situation of each EU Member States. Specific reference to discrimination on the ground of ethnicity is made to five Member States (Belgium, Denmark, France, Netherlands and Sweden) in the context of discrimination against migrant workers. As a next step, Member States will submit their National Reforms Programmes by April.



# Member States of the Council of Europe reaffirm their support for the European Convention of Human Rights (ECHR)

The 47 member states of the Council of Europe have reaffirmed their support for the European Convention on Human Rights (ECHR) and agreed on a series of measures to improve the implementation of judgments from the Strasbourg court. More information is available here.

# International Day for the Elimination of Racial Discrimination: joint statement by Heads of European human rights institutions

20th March is the International Day for the Elimination of Racial Discrimination. On this occasion, the Heads of three intergovernmental human rights institutions (ODIHR, ECRI and FRA) published a joint statement recalling that the most effective way to counter hate speech is to reinforce the fundamental values of democracy and human rights.



## **Sexual Orientation & Gender Identity**

The Congress of the Council of Europe adopts the resolution "Guaranteeing the rights of LGBT people at local and regional level"



The resolution calls on local and regional authorities to take up action to fight discrimination against LGBT people.
