My motivation for becoming a member of the Equinet Executive Board: (please explain why you would like to sit on the Equinet Executive Board)

There are two main reasons why I'd like to continue my work as a member of the Equinet Executive Board. First of all, in the past two years I have been involved in the preparation of the strategic plan of our organization for the years 2015-2018. It was a very exciting process, which allowed me to get to know the opinions and needs of member organizations. I do believe in future goals of Equinet and I'd like to participate in their implementation. Secondly, I have worked at the Office of the Human Rights Defender in Poland, which has very wide range of competencies. In addition to its function of the national human rights institution, it is also became an equality body, and since 2012 also an independent institution for monitoring implementation of the Convention on the Rights of Persons with Disabilities. The regulations of the Polish Constitution allow the Ombudsman to take action in any case of infringement of the principle of equal treatment, regardless of its grounds and area of discrimination. As a result, the Office of the Human Rights Defender considers about 1.000 complaints about violation of the principle of equal treatment a year. This makes me deal with the full range of issues connected with this area. The powers granted to the Ombudsman also allow the selection of the most effective measures against discrimination. In practice of operation of the Polish office for equal treatment we have put, among others, motions to the Polish Constitutional Tribunal (including matters of equal treatment, discrimination on the grounds of gender, age and disability), lodging legal remedies in court proceedings (including proceedings against discrimination on the grounds of race and age) as well as the so-called indirect legislative initiatives (including in the area of equal treatment regardless of sexual identity, gender, age and disability). Working in the Office of the Ombudsman has allowed me to gain a lot of experience in the field of research on discrimination. My recent research included the issues of prevention of discrimination on the grounds of disability, age, sex, sexual orientation, gender identity and religion. I am convinced that this broad perspective may be valuable for such an organisation as Equinet, and my experience regarding various measures of prevention of discrimination on multiple grounds will be useful in the tasks of Executive Board.

Additional note or other relevant information relating to your application (if any):

In the Office of the Human Rights Defender I occupy position of deputy director of the Department for Equal Treatment and Protection of the Rights of Persons with Disabilities and Secretary of the Experts' Committee on the Rights of People with Disabilities. I coordinate the work of the Unit of Anti-Discrimination Law. I am a lawyer, a graduate of the Law and Administration Faculty at University of Warsaw. I completed postgraduate studies in public international law as well as European law and legislation issues at the University of Warsaw and Foreign Policy Studies at the Diplomatic Academy of the Polish Institute of International Affairs. I have been a member of non-governmental organisations for many years. I am the author and editor of numerous publications and reports of the Human Rights Defender on prevention of discrimination. I am writing a doctoral dissertation on the UN Convention on the Rights of Persons with Disabilities. I am an attorney, member of the Regional Chamber of Barristers in Warsaw. Since 2013 I've been a member of the Equinet Executive Board.
