Objectives

- A. Assess developments comparing EU-MIDIS I (2008), Roma survey (2011) → EU-MIDIS II (2016)
- B. Comparable (equality) data in EU-28
- C. Provide data for core indicators (social inclusion / integration / equality and non-discrimination), for example:
 - SDG indicators
 - Europe 2020 indicators
 - Roma inclusion indicators
 - Indicators on immigrant integration
- D. Refine survey methodologies for hard-to-reach populations




EU-MIDIS II target groups

- Immigrants and their descendants: based on their country of birth or country of birth of the parents
 - Turkey (6 EU MSs)
 - North Africa (5 EU MSs)
 - Sub-Sahara (12 EU MSs)
 - Asia / South Asia (4 EU MSs)
- Recent immigrants: immigrated within the last 10 years (2 EU MSs)
- Russian minority: self-identification (3 EU MSs)
- Roma: self-identification (9 EU MSs)



EU-MIDIS II target groups







EU-MIDIS II: Sample (preliminary information)

Random sample of 25,515 respondents:

- 7,947 Roma respondents in households with 33,785 persons, including 11,613 children (<16 years)</p>
- 1,419 Russian respondents in households with 2,979 persons
- ➤ 16,149 Immigrants (1st gen.) /descendants (2nd gen.) in households with 40,895 persons

= sections include questions that follow a similar format and sequence



For example: Rights awareness, perceptions

- Perceptions of the extent of discrimination on grounds of skin colour/ethnic origin/ religion or religious belief in the country (3 items) (Eurobarometer, EU-MIDIS I)
- Awareness of Equality Bodies or other organisations that offer support (EU-MIDIS I, other FRA surveys)
- Awareness of anti-discrimination laws (EU-MIDIS I, other FRA surveys)
- Awareness of anti-discrimination campaigns in the past 12 months in [country] (+ for countries where ROMA are surveyed: DOSTA! campaign) (EU-MIDIS I, other FRA surveys)



For example: Identification, fear of victimisation

- Attachment to local area/country/Europe (5 items)
- Self-identification as national/European/ethnic minority/country national of CoB/CoB of parents (5 items)
- Fear of being victimised/ harassed/ physically attacked when out in public because of ethnic or immigrant background (3 items)
- Avoidance of certain places for fear of being treated badly because of ethnic or immigrant background



For example: Situations of discriminatory treatment at work

- Receiving tasks below one's qualifications
- Being denied promotion
- Not allowed to join a trade union
- Not allowed to take time off for important religious holiday/service/ceremony
- Being fired, dismissed or laid off
- Prevented from expressing or carrying out religious practices or customs, such as praying or wearing a headscarf

...due to ethnic or immigrant background



For example: Experiences of threats and harassment

- Experience in the past 5 years before the survey of incidents where somebody...
 - made offensive or threatening comments to you in person such as insulting you or calling you names?
 - threatened you with violence in person?
 - made offensive gestures to you or stared at you inappropriately?
 - sent you emails or text messages (SMS) that were offensive or threatening?
 - posted offensive comments about you on the internet, for example on Facebook or Twitter?
- Details concerning incidents of harassment, such as reporting
