Equality bodies tackling Discrimination against Persons with Intellectual Disabilities

Thursday 9th and Friday 10th March 2017

BACKGROUND INFORMATION AND CONTEXT

Discrimination against persons with intellectual disabilities touches upon many areas of life. Despite the ratification of the <u>UN Convention on the Rights of Persons with Disabilities (CRPD)</u> by 27 EU Member States and the European Union itself, challenges in legislation and practice remain for persons with intellectual disabilities.

Several national and international reports highlight these challenges, such as <u>legal capacity</u>, <u>political participation</u>, <u>the right to independent living</u>, or the <u>specific situation of women with intellectual disabilities</u>. Specific reports and data focusing on persons with intellectual disabilities in Europe are however rare.

The majority of Equinet members have a mandate to address **discrimination on the ground of disability**. In 2014, the Perspective <u>"Realising Rights. Equality bodies and people with disabilities.</u> <u>Supporting the review of the European Union Disability Strategy 2010-2020"</u> revealed that 7 of them undertook specific activities to engage persons with intellectual disabilities in their work. This includes for instance delivering self-advocacy training, producing awareness raising tools about their rights and engaging with non-governmental organisations advocating for the rights of persons with disabilities.

Given the specific situation of persons with intellectual disabilities and the numerous challenges they face on the ground of disability and on other grounds of discrimination, there is a strong potential and demand from Equinet membership to build their capacity in this area.

OBJECTIVES

The main objective of the Seminar is **building individual capacity of equality bodies' staff members** to address discrimination against persons with intellectual disabilities.

In particular, the Seminar aims to:

- Help equality bodies with **understanding and clarifying the main concepts** related to discrimination against persons with intellectual disabilities.
- Provide them with **practical guidance** on how to address discrimination against persons with intellectual disabilities from a **legal, policy and communication perspective**.
- Stimulate and support peer learning.

PARTICIPANTS

This Equinet seminar is dedicated to an audience of approximately **45 equality bodies' staff members dealing with disability issues**. It allows for participation with different professional backgrounds, including **legal, policy and communication**. Participants will follow different workshops according to their area of expertise.
