# Call for Candidates

### Deadline for candidate nominations: Thursday 7 September 2017

The Chair of the Equinet Executive Board and the Equinet Executive Director hereby call upon all Equinet member organisations to consider **nominating a candidate for the election of the new Executive Board** (maximum one per member organisation).

The nine members of the next Equinet Board will be elected by secret ballot for a two-year mandate (October 2017-October 2019) by the General Assembly of Equinet Members at the Annual General Meeting (AGM) on Wednesday 11 October 2017 in Brussels. We hereby invite you to note and save the date to ensure your attendance at this important event gathering all Equality bodies.

The **full elections procedures** and **eligibility requirements** are detailed and explained in the **Equinet Board Elections Guide** (http://www.equineteurope.org/-EQUINET-2017-BOARD-ELECTIONS-).

#### Main responsibilities of the Board Members

- **Continued and pro-active involvement** in the development and implementation of Equinet strategies and activities, overseeing of the Equinet budget and the work of the Secretariat.
- To attend Board meetings. Four Board meetings take place in Brussels or other European cities each year.
- To attend and actively participate in Equinet Annual General Meetings (AGM).
- To actively participate in selected Equinet conferences, seminars, trainings and/or working group(s).
- To provide feedback on regular requests and consultations circulated by the Chair or Equinet Secretariat
  between Board meetings throughout the year.

#### Next Steps - What is expected from Equinet member organisations?

- Member organisations are all invited to informally communicate their intention regarding the possible nomination of a candidate by using the **Online Declaration of Interest form** (see "Registration of interest" below).
- Member organisations that have already selected a candidate can submit the **full candidacy information** (see "Equinet Board Member Candidate Nominations" below) at their earliest convenience.

#### Registration of Interest (By Tuesday 18th July 2017)

Member organisations are now invited to communicate their **intention to nominate a candidate** by using the **Online Declaration of Interest** or by **sending an email** to Anne Gaspard, Equinet Executive Director (anne.gaspard@equineteurope.org) by **Tuesday 18th July 2018**.

#### Candidate Nomination Form (By Thursday 7th September 2017)

- Formal candidate nominations will be exclusively communicated via the dedicated **Candidate Nomination Form**.
- A candidate nomination form will be valid only if it is **duly completed and signed**, and **accompanied by the compulsory information** (CV in English).
- The form can be **mailed or emailed to the Equinet Secretariat**, to the attention of Anne Gaspard, Equinet Executive Director (anne.gaspard@equineteurope.org).
- Nominated candidates must be able to attend in person the **Annual General Meeting on Wednesday**11th October in Brussels.
- The final deadline for submissions of candidate nomination forms is Thursday 7th September.

Equinet members are encouraged to nominate candidates with a view to ensuring the diversity and gender balance of the Board.
