Equinet is celebrating its 10<sup>th</sup> anniversary. It seems that Equinet had very successful decade. Satisfaction among members and relevant stakeholders remains very high, network enjoys high level of credibility within the EU system and volume of activities is stable. My first two years on the Executive Board were period of learning the basics and representing Equinet at international level (EU, UN, Council of Europe) always with great honour.

We shall bring big data and individual stories to eyes of politicians, media and public. We shall address greater complexity that came with our success. My 5 main priorities are as follows:

- Help Equinet members to litigate at national level on strategic issues ("individual cases")
- Establish permanent Working Group on Research and Data Collection ("big data")
- Launch Equinet Academy with fixed amount of regular seminars and trainings on highly demanded topics ("building capacity of network sustainably")
- Fight strongly for Standards of Equality Bodies with clear vision ("top political level EC Recommendation")
- Adopt transparent policy on public statement positioning ("embracing vari-speed Europe")
