# UNIA



- Independent public institution
  - combats discrimination
  - promotes equal opportunities
- Processing individual reports of discrimination
- Reporting, studies, research...
- Policy recommendations
- Awareness raising and training

## Grounds 'fortune' and 'social origin'

2 grounds in the Federal Belgian antidiscrimination legislation :

- “fortune” : financial resources
  - “social origin” : belonging to a certain social class (heritage)
- +
- At the *Flemish Community* level -> “social condition” :  
larger than social origin...

Recommendation from Unia:

- change “social origin” -> “social condition”,  
to take into account a broader range of situations, like family  
composition (lone parenthood), place of residence (in deprived  
areas...)...


In 2016:

- 5 % of the complaints are based on the ground of fortune
- 91% of the complaints based on fortune are related to housing

Graphique 61 : Nouveaux dossiers « Unia compétent » 2016 - fortune par domaine (1)

Typically:

A landlord refusing to rent to social assistance beneficiaries or unemployed people.



Position Unia:

Selecting a tenant on basis of the amount of his income, to be sure he can pay the rent each month, is OK.

Refusing to rent because someone is a benefit recipient or requiring a specific form of employment contract is discrimination.

## 2 CASES BROUGHT BEFORE COURT

- A landlord requires a permanent employment contract from tenants.

The court says the landlord exceeds what should normally be required from a tenant. No legitimate goal in asking a permanent contract.
- Barriers:
  - In general, it is difficult to prove discrimination
  - Difficulties for people, especially the poor, to reach Unia

### **Diversity Barometer - Housing and Education :**

- Attempt to measure discrimination towards specific target groups
- But also tolerance /attitudes towards these groups and the participation of these groups in society.
- Combines qualitative and quantitative research methods.



Setting up a universal guarantee fund, etc.

Figure 2 : Orientation à 15 ans, selon l'indice socio-économique (par décile)



Flemish community,

Figures for French community are very similar

With same results:

- Students whose parents are low skilled /blue-collar workers are more likely to be oriented in less rewarded, vocational studies which prepares to a quick entry in employment.
- Students whose parents are high skilled workers (executives...), are more likely to be maintained in academic studies, to preserve their chance to achieve higher education.

Recommendations:

Train the teachers to get along with the diversity of students.

Enhance the links between the school and the parents.

Improve the decision process for the study orientation of the students, etc.

# Combat Poverty Service

---

- Cooperation Agreement between the federal State, the Regions and the Communities, approved by the Parliaments (1999), installing the Combat Poverty Service
  - The Service acts in independancy
  - Poverty in terms of human rights
  - Mission: to evaluate the effectiveness of fundamental rights in situations of poverty and to do recommendations

# Evaluation of the effectiveness of fundamental rights, with the implication of people in poverty

- Method: the Service organises dialogue processes with participation of different stakeholders, with a special attention on people living in poverty and their organizations (collective approach)

The results of these thematical exchanges/dialogues (analysis and recommendations) are published in the bi-annual reports of the Service, addressed to the different governments, parliaments and their advisory structures. Are also used in memoranda (elections), notes, ...



- Ex post evaluation:

For example: rental guarantee

- working group about rental guarantee: proposal of a central/universal guarantee fund
- analysis of new regulation in the three Regions with two criteria: affordability and risk on stigmatization (discrimination)



- Ex ante evaluation

- working group with several stakeholders about the instrument of a ‘poverty impact analysis’ or ‘poverty test’
- experiences in some ‘poverty impact analysis’ in the Flemish Region: new tarification water (water bills), child benefits, smart meters energy,  
...



- Jurisprudence

- Publication of summaries of decisions from national and international courts



- Importance of the recognition of poverty because of non-take-up of rights
  - not evident for people in poverty to go to anti-discrimination institutions or courts: under-reporting in complaints

- different reasons for non-take-up: more than lack of information, and the procedure problems, ... also stigma, expected consequences of the demand... and not-awareness to be a subject of rights
