On 12 September, 20 former employees of internationally renowned artist Jan Fabre wrote an anonymous open letter, denouncing the toxic culture of abuse of power, sexism, sexual harassment and sexually transgressive behaviour in Jan Fabre's theatre company Troubleyn. With the letter they wanted to break the culture of silence and strive for an open, conscious and respectful working environment in the media and cultural sector.

A few weeks before the letter appeared, one of its writers contacted the Institute for the equality of women and men. She asked if the Institute could help the group by acting as a media buffer. None of the writers wanted to be caught in a media storm or become the recognisable face of the open letter. In the hours and days following the publication of the letter, the Institute answered the enormous number of press questions and

The news was picked up by various international media, in the Netherlands, France, Germany and the United States. The Public Prosecutor's Office of the Antwerp Labour Auditor started an investigation into Jan Fabre and his theatre company.

As a result of the case, the Institute received several reports from victims and witnesses who concurred with the content of the open letter. The open letter opened the debate in Flanders on transgressive behaviour in the media and culture sector. In the aftermath, the Flemish Minister of Culture and Media appointed an ombudsperson for the cultural and audiovisual sector
