Cancellation & Reduction Policy

A cancellation must be communicated to the Hotel in writing. No rights can be derived from a verbal cancellation. The day of receipt of the letter or e-mail will be considered as the final cancellation date. The postponement of the Event is considered the same as a cancellation and therefore these terms and conditions also apply to a postponement. The total value of the reservation, based on the most recent confirmation of the group, event or congress, is the base for the calculation of the amount which EQUINET EUROPEAN NETWORK OF EQUALITY BODIES must pay to the Hotel.

If at any time within the cancellation deadline more than the granted free reduction is either cancelled, modified or reduced, this additional amount will be charged 100% of the contracted value.

No Show

In the event of no show, the customer will, in all cases, be required to pay 100% of the reservation value (including VAT).

Special Provisions Covid-19 & Social Distancing

EQUINET EUROPEAN NETWORK OF EQUALITY BODIES is aware of the fact that this Agreement has been drawn up on the basis of the capabilities that the Hotel can offer without observing the social distancing rules. In the event that the social distancing requirements are still in effect within a reasonable time prior to the Event, the Parties shall attempt to postpone the Event to a new date. In case a postponement cannot be agreed on, the Hotel reserves the right to relocate the Event to another hotel, or to split the Event into different (meeting) rooms. In case division or relocation to another hotel is not possible, the Hotel reserves the right to terminate the Agreement. The Hotel will not be liable for any damages as a result of this termination.

Force Majeure

EQUINET EUROPEAN NETWORK OF EQUALITY BODIES and the Hotel may cancel this Agreement without liability as a result of Force Majeure occurring after the conclusion of the Agreement. Force Majeure means unforeseen circumstances beyond the control of either party that make it impossible or illegal to materially perform the respective obligations under this Agreement.

Before EQUINET EUROPEAN NETWORK OF EQUALITY BODIES is entitled to invoke its right to cancel the Event due to Force Majeur, EQUINET EUROPEAN NETWORK OF EQUALITY BODIES shall consult with the Hotel to reschedule the Event to a new date. If the parties fail to agree on a postponement date, the Hotel shall return the deposits to EQUINET EUROPEAN NETWORK OF EQUALITY BODIES within sixty (60) days. The Hotel may deduct from the deposit any expenses incurred by the Hotel or any third party in connection with the performance of this Agreement. In case these costs exceed the amount of the deposit, the amount due must be paid to the Hotel by EQUINET EUROPEAN NETWORK OF EQUALITY BODIES within thirty (30) days.

Final Provision

If at any time one or more provisions in the Agreement are wholly or partially null and/or void and/or nullified, the other provisions in this Agreement will remain in full force and effect.

Damages

a) The Hotel has an insurance that covers the risks of Fire, Flooding, Robbery of guest's belongings and personal injury (liability insurance). Theft of guest's belongings is only covered when there is burglary damage to the rooms. Loss of guest's belongings are not covered.

b) Except in the event of proven blame attributable to the Hotel or to its employees, the EQUINET EUROPEAN NETWORK OF EQUALITY BODIES shall be liable for all personal or material damage which might occur during execution of the agreement and shall take out, at his exclusive cost, such insurance as he deems necessary for this purpose.

c) The EQUINET EUROPEAN NETWORK OF EQUALITY BODIES shall be liable for any damage that the audiovisual equipment under contract or other property of the Hotel may sustain when such damage is the result of manifest misconduct or negligence by the EQUINET EUROPEAN NETWORK OF EQUALITY BODIES or the attendees at the event.

d) Except as indicated in paragraph a) above, the EQUINET EUROPEAN NETWORK OF EQUALITY BODIES shall be liable for all damage of any type suffered by materials, effects, documentation or any type of equipment not belonging to the Hotel or installed at the request of the EQUINET EUROPEAN NETWORK OF EQUALITY BODIES for the execution of the contract.

No official suppliers

Any project of decoration, technical installations and/or sundry fittings out of the Hotel rooms, lounges and meeting rooms will have to be agreed beforehand in writing by the management of the Hotel and carried out in accordance with current regulations and safety rules.

@EQUINET EUROPEAN NETWORK OF EQUALITY BODIES must provide the HOTEL with the project of set up /decoration of the spaces contracted at least 30 days before the event start date.

The Hotel will study it and come back to the client with approval or denial.

Any approval which might be granted will always and under all circumstances exclude any manner of perforation of floors and cladding materials of the fixing of posters which require the use of adhesive or glues on the walls, ceilings or floors of the premises being the object of the contract.

In the HOTEL, painting as well as noisy works are not allowed.
